

Notice of Open Tendering of the Construction of Pumps and Pipelines to Transport Rainwater from the Ash Yard to the Cooling Tower Basin Project for BEPCL

1. Tendering Condition

According to the plan of Barisal Electric Power Company Limited (hereinafter referred to as “BEPCL”), the construction of pumps and pipelines to transport rainwater from the ash yard to the cooling tower basin project shall be procured.

2. Project Overview and Scope of RFQ

2.1 Scope: This project is mainly to recycle rainwater in the ash yard of the plant and use it as circulating cooling water in the plant. The work includes equipment procurement, civil construction, equipment installation and system commissioning, etc.

2.2 Destination: Project Site of BEPCL at Taltali, Barguna District, Barishal City.

2.3 Contract Period: 50 days from the date of signing of the contract.

2.4 Quality requirement: Meet the requirements specified in Technical specifications, and finally obtain Party A's acceptance.

3. Bidder Qualification Requirements

3.1 The bidder must be legally registered locally and provide the relevant basic documentation.

3.2 The bidder is a legitimate taxpayer and able to issue Mushak 6.3 invoices.

3.3 The bidder has at least 2 years of experience in civil work.

3.4 The bidder must have good bank credit and commercial reputation, and must not be under an order to cease operations, or in a state of receivership, asset freeze, or bankruptcy.

3.5 Joint venture is not accepted for this tender.

4. Acquisition of the Tender Documents

4.1 When the bidder applying for the tender documents, a scanned copy of the agent's ID and an authorization letter issued by the legal representative (stamped with the official seal) specifically for purchasing the tender documents for this project must be submitted.

4.2 The bidder who is interested in participating in this bid is requested to submit all company documents, including the Company Profile, BIN, TIN, Certificate of Registration, Proof of the Latest Tax Return, Civil Work Experience List, and the documents mentioned in 4.1 to the following email by June 22, 2025. Potential bidders who pass the prequalification process will receive the tender documents via email from BEPCL.

4.3 There is no charge for purchasing the tender documents for this bid.

5. Submission of the Bid

5.1 Deadline of Submission of Bid: 05 PM, June 28, 2025.

5.2 Bid documents not sent to the specified email address by the deadline will not be accepted by the tenderer.

5.3 If there are any changes to the bid submission deadline or submission location, the tenderer will promptly notify all potential bidders who have purchased the tender documents in writing.
